

## Preliminary information form for preparatory instruction

Preparatory instruction is provided for pupils between the ages of 6 and 10 for no less than 900 lessons, and for older pupils, no less than 1000 lessons. This is roughly equivalent to one year of schooling.

A 16-year-old will be directed to preparatory instruction in the context of basic education for children, unless they can present a certificate of their primary and lower secondary education equivalent to the Finnish basic education graduation certificate.

If they have a graduation certificate, they will be directed to other forms of instruction (TUVA preparatory education for an upper secondary qualification, intermediate studies in adult basic education, liberal adult education courses for those subject to compulsory education, upper secondary schools).
